SECOND VICE-PRESIDENT'S REPORT:

TREASURER'S REPORT:

The Year-to-Date Income and Expenses was presented. At the end of April, the JRC had 451 members in good standing, and there has been good support from the clubs. Summer members will be charged half the annual dues for half the year.

Terms have been changed for art displays in the hall, requiring a small amount of rent and reduced percentage of purchases.

The new tables were a major purchase, and maintenance costs were experienced, as required by a fire department inspection.

PRESIDENT'S REPORT:

Search is continuing for a substitute for the Office Administrator who will be absent in June. The President will place an ad in the paper for same.

Pinedorado volunteers are needed for the annual breakfast.

The President will contact the County for needed exterior painting.

Kitchen cleaning will be done after the annual fish fry.

NEW BUSINESS:

A request has been received to either replace or upgrade the current sound system which is old and difficult to operate. A proposal of \$2000.00 has been received to replace the system. Because there have been a number of varied complaints, Sal Buongiorno suggested that concerns be submitted in written form before we buy the system. Jim Major and Joel Cehn will act as interface between the supplier/installer and club members. Sharon Heyne moved, seconded by Maryann Grau, that we approve the purchase of a new sound system, under the advice of Joel Cehn and Steven White, not to exceed \$2500.00. Discussion followed. It was stipulated that the existing speakers and amplifier remain. The motion passed with one abstention.

OLD BUSINESS:

Jim Major moved, seconded by Francesca Bolognini, that the Stay-at-Home club, having met the criteria, be accepted as a JRC club. Motion carried.

ADJOURNMENT:

Sharon Heyne moved that the meeting be adjourned. Sal Buongiorno seconded the motion. The meeting adjourned at 9:50 a.m.
